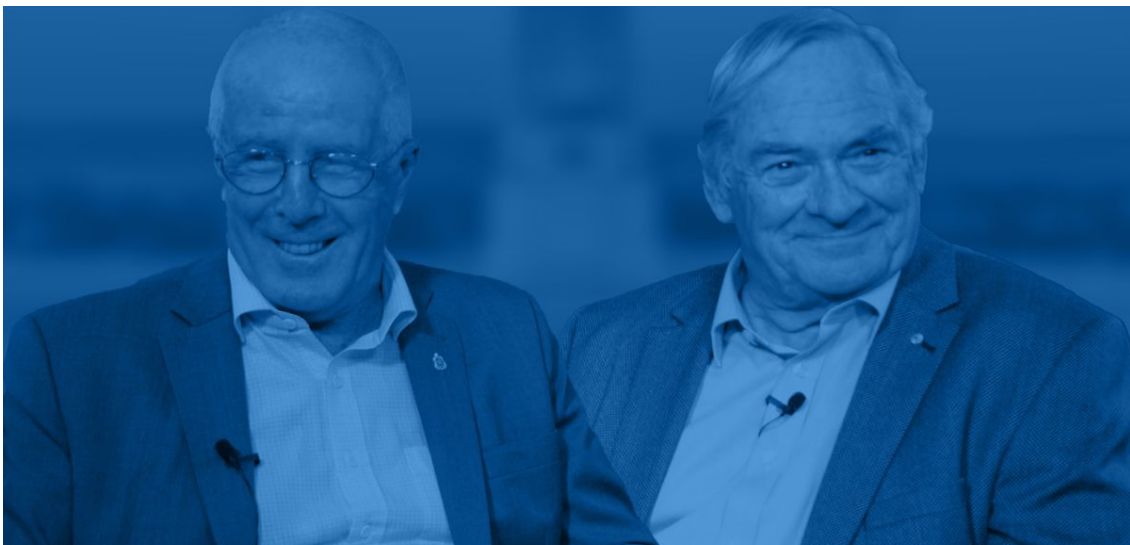

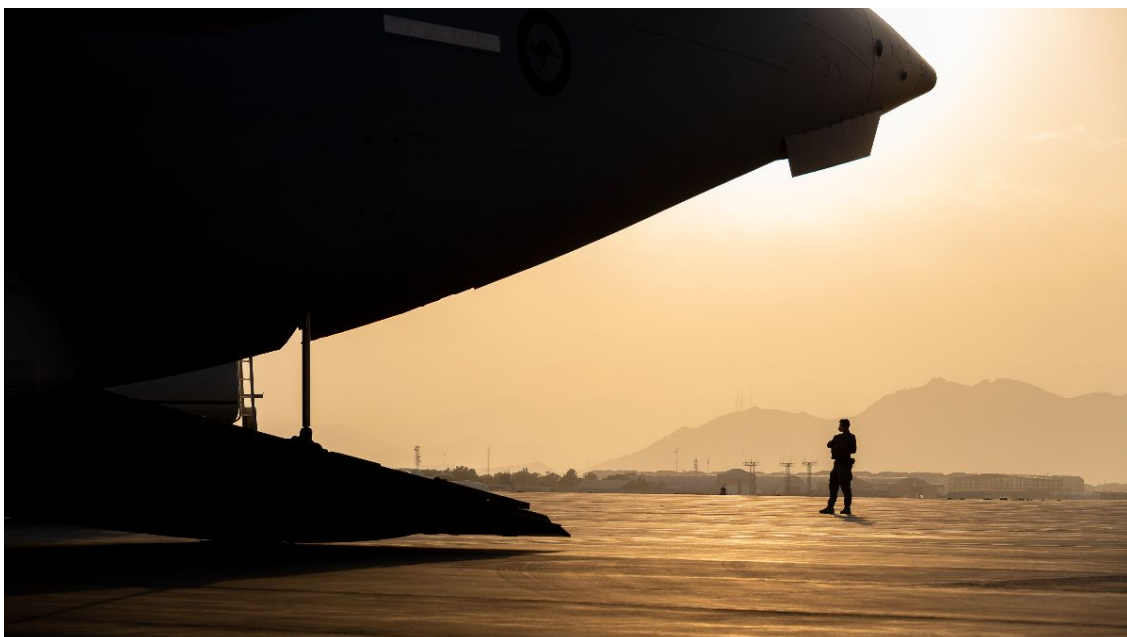
### Podcast

A recent alleged attempted mugging incident at the Osborne Park RSL Sub-Branch involving the Secretary, his wife and another elderly member, has prompted a reminder that we all need to be situationally aware of our surroundings at all times.

It's highly unfortunate that we have people within our communities who seek out 'soft targets' in older people and venues where there is likely less security or less people to witness such attacks.

Vigilance could mean simple actions such as leaving in larger groups or just watching for others as they make their way through the car park, to installing more lighting and additional security if budgets permit.

To hear that our members have had to endure this type of abuse is not something that should be taken lightly. Stay vigilant and keep the RSLWA community safer.
